2. Society Shall make clear the fee and other financial structure and modus operandi in working as a charitable institution rather than as a commercial society in the garb of the aforesaid Act.
3. This should be a charitable society run on no profit no loss basis.
4. There should be a proper infrastructure, playground, etc. to run educational society, with proper sitting arrangements in the adequate ventilated rooms.
5. It should abide by rules, regulations and instructions adopted by the society.
6. The society shall have no right for demanding financial assistance or the land from the H.P. Govt. through its concerned departments.
7. The Society will also abide by the instructions and directions of the Registering Authority as well as of the Education Department of the H.P. Government.
8. The society will not admit students in the educational institution without getting proper permission and affiliation of affiliating body concerned.
9. The Society will ensure complete transparency in its functioning. Compliance be submitted to this office also.








NO MEMBER OF THE SOCIETY SHALL HAVE ANY PERSONAL CLAIM ON ANY MOVABLE OR IMMOVABLE PROPERTIES OF THE SOCIETY OR MAKE ANY PROFITS WHATSOEVER BY VIRTUE OF MEMBERSHIP.
